

## Admissions Policy for Nursery 2018-19 Appendix

1. The Governors intend to admit up to 52 children arranged as set out in the tables below.

<b>Option 1: 15 hours</b>	4 places for FEET* funded 2 year olds 22 places for FEE** funded 3 and 4 year olds
Monday: 9.00am – 3.00pm (6 hours)	Lunch to be purchased from school (£2.25 per day) or provided by parents

<b>+15 Full Time Option: 30 hours (subject to availability)</b>	15 hours FEET* or FEE** funded plus 15 hours funded by +15 eligibility

### Children eligible for FEET and FEE Funding

2. Parents will be asked to give a preference for Option 1 or Option 2. On the application form, parents that qualify for +15 hours may wish to express an interest to for a +15 full time place subject to availability.
3. Account will be taken of any preferences expressed by parents but places will be allocated subject to availability and are not guaranteed. If the preferred option is unavailable, an alternative place may be offered.

### **Children not eligible for FEET funding**

4. If a place is available for a 2 year child not eligible for FEET funding, charges will apply of £6 per hour until the term after they turn 3 which is when they become eligible for FEE funding.

### **+ 15 Full Time Option**

5. Places will be allocated to Options 1 and 2 in the first instance. If places are still available in either option, in the equivalent age range, once all FEE funded places have been allocated and accepted, places will then be offered to applicants who would like to be considered for a + 15 full time place and are able to provide an eligibility code. The oversubscription criteria set out in section 2 of the Admissions Policy will be applied to allocated places.
